

## “YOUNG THE GIANT TICKET GIVEAWAY” Official Rules

PURCHASE IS NECESSARY TO RECEIVE TICKETS. LIMITED TO ONE PAIR OF TICKETS PER ALBUM. VOID WHERE PROHIBITED.

1. Eligibility: The “Young The Giant Ticket Giveaway” (“Giveaway”) is open to legal residents of the United States who are at least 18 years old at the time of participation. Purchase is necessary to receive tickets. All purchases must be completed during the Giveaway Period.
2. Sponsor: The Giveaway is sponsored by Vinyl Street Co., located at 1895c Post Road, Fairfield, CT, 06824.
3. Agreement to Official Rules: By participating, participants agree to be fully and unconditionally bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Giveaway.
4. Giveaway Period: Purchases will be accepted starting on Sunday, May 25, 2026, at 12:00pm ET (when business opens), and ending when both albums designated with tickets have been purchased & claimed on Sunday, May 25, 2026, or by 6:00pm ET (“Giveaway Period”). All purchases must be completed by Sunday, August 17, 2025, 5:00pm ET.
5. How to Receive Tickets (In-Store ONLY / No Online or Social Media component): Purchase one of two copies of Young The Giant’s “Victory Garden” vinyl record, each with a pair of tickets designated to it. To claim tickets, you must provide your name and contact information upon offer during regular business hours (subject to change). Limit one purchase per person / one pair of tickets per person. Purchases that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor.
6. Prizes: Two (2) purchasers of the designated albums will each receive two (2) tickets to Young The Giant live on Saturday, June 13, 2026 at the Hartford Healthcare Amphitheater in

Bridgeport, CT. Approximate face value (AFV): approx. \$49.00 per ticket (subject to change). No cash or other prize substitution shall be permitted except at the Sponsor's discretion. The prize is non-transferable, non-redeemable, and not exchangeable for cash. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of the recipient.

7. Odds: The odds of receiving tickets depends if you purchase one of the two albums that come with a pair of tickets.

8. The Sponsor shall have no liability for a recipient's failure to receive notices due to spam, junk email, or other security settings or for a recipient's provision of incorrect or otherwise non-functioning contact information.

Rights Granted by You: By participating in this Giveaway, you understand and agree that the Sponsor, anyone acting on behalf of the Sponsor, and the Sponsor's licensees, successors, and assigns shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media your entry, name, portrait, picture, voice, likeness, image, statements about the Giveaway, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes without any further compensation, notice, review, or consent.
